Salient points pertaining to this tender are furnished below –

**1. Type of Tender:** Tenders are invited in two part system, namely Part-I & Part-II tender. While Part-I tender is meant for pre-qualification, Part-II is meant for price bid. Part-I tender will contain terms and conditions of contract and documentary evidence in support of credentials of the tenderers. Part-II tender will contain price bid only. Part-II tender of only those tenderers will be opened who will qualify on the basis of credentials submitted in Part-I tender.

**2. Earnest Money:** The Earnest Money as mentioned above may be deposited in the form of Demand Draft in favour of Eastern Coalfields Limited A/c Sonapur Bazari Area on any scheduled Bank payable at its branch at Asansol. The Earnest Money is to be deposited in a separate envelope. A tender without earnest money shall be summarily rejected.

**7. OTHER INSTRUCTIONS :**

Mere issue of tender document to intending bidders will not mean that they have fulfilled the requisite qualifications. Part-I and Part-II tender document duly filled in, as required, and signed on each page are to be submitted by the tenderers. Incomplete tender document not properly filled in shall be summarily rejected. Also non- submission of issued tender documents will lead to summary rejection of tender. The xerox copies of all the certificates submitted shall be legible and duly signed by the tenderer. The decision in respect of Part-I tenders shall be taken solely on the basis of documents / certificates submitted by the tenderers in Part – I tender. Successful tenderer has to provide the brand new vehicle to the company within 15 days of issue of work order to him or on 01.04.2012 whichever is later.

**8. DISPLAY OF TENDER DOCUMENT ON WEB SITE:-**

Tender documents can be down loaded from our website [www.easterncoal.gov.in](http://www.easterncoal.gov.in) and from Website of NIC <http://tenders.gov.in> during the period of sale of tender documents. In case of tender document obtained by down loading from website, cost of tender document shall have to be deposited by the tenderer in the form of demand draft drawn in favour of Eastern Coalfields Limited A/c Sonepur Bazari Area payable at Asansol which is not refundable. Tenderers shall be solely responsible for the correctness of down loaded tender documents. Submission of incomplete down loaded tender documents will be rejected.

The bidders will be required to submit an undertaking that they will accept the tender documents as available in the web site and their tender shall be rejected if any tampering in the tender documents is found to be done at the time of opening of tender.

**9. MODE OF SUBMISSION OF TENDER :-**

2. The cost of mobil at the rate of Rs. 155.00 per liter may be reimbursed on the request of contractor by the company as per norms of Sonapur Bazari Area as given in Part II
3. The vehicle shall be maintained in good running condition by the vehicle owner
4. You shall pay your employees as per Payment of minimum wages act and payment shall be made through bank only.
5. Milometer shall be kept in order without fail and the log book shall be maintained daily and shall be produced to the in-charge of vehicle for counter signature
6. The vehicle shall be made available to the company with driver etc. having valid driving license for round the clock except at Sl. No.24 which shall be deployed for 12 hrs only. If the vehicle is not provided due to any reason penalty shall be imposed at double the rate of hire charges per day.
7. The contractor shall be liable to pay the compensation to your employees in case of accident as per Workmen's compensation act.
8. The alternate vehicle shall be provided by you in case of breakdown of the vehicle or repair/maintenance of vehicle.
9. If the performance of the vehicle or behavior of the driver is not found satisfactory the Company may terminate the contract.
